**Two Accused In Hells Angels Shooting Try For Bail**

It's been a long day in court for two defendants in last week's double shooting case involving the Hells Angels biker gang.

After several delays this morning, the bail hearings for 26-year-old Andre Williams and 26-year-old Germaine Phillpotts got underway in earnest close to 11:30 a.m.

The two men sat in the prisoners' booth listening as Assistant Crown Attorney Meredith Gardiner and their defence attorneys spoke to Justice of the Peace Cheri Emrich.

Both Williams and Phillpotts face a number of charges.

Williams, who is from London, has been charged with attempted murder, aggravated assault, use of a firearm and pointing a firearm.

Phillpotts is a Brampton native and is up on a charge of accessory after the fact to attempted murder.

Each of the men also face a couple of other firearm related counts.

Another suspect in the case, 25-year-old Bevrol Campbell faces the same charges as Phillpotts and was also scheduled to make a court appearance today although not for bail.

The fourth suspect, 26-year-old Nikota Martin, is still at large.

Most of today's hearing has been taken up by testimony from a member of the London Police. The officer was also cross-examined by both defence councillors.

The nature of the testimony can't be reported because a wide-reaching publication ban has been placed on the case.

Phillpotts's lawyer, Jordana Goldlist tells AM980 her client's resolve is firm.

"All I can say at this point is that Mr. Phillpotts is vigorously denying these allegations, will be defending these charges and has continually done so since first contact with me upon his arrest," she says.

Goldlist says she hopes to secure bail for Phillpotts this afternoon.

She says the case is taking a toll on her client's family.

"Mr. Phillpott's family is quite concerned. This is an individual with no criminal record whatsoever so allegations of this nature are shocking, they're surprising," she says.

"He has a lot of family support behind him as well as friends who have contacted me and all are prepared to support him as he defends these allegations," Goldlist says.

It was early last Wednesday morning when police say a full patch member of the Hells Angels and a female associate of his were shot on Grey Street near a building associated the the biker club.

The man was left with serious injuries and the woman was later released from hospital.

Today's hearing is expected to continue throughout the afternoon.
